OFFICIAL GAME RULES

“Connecticut MEGA MILLIONS”

Please take notice that the Connecticut Lottery Corporation (“CLC”) duly adopted, with the advice and consent of its Board of Directors, the following game rules (“Official Game Rules”) governing the operation of its “Connecticut MEGA MILLIONS” program, which rules were adopted on January 7, 2010 and amended on January 28, 2010, June 24, 2010, December 2, 2010 and February 23, 2012.

The following Official Game Rules apply unless otherwise inconsistent with the game rules established by the Mega Millions Lotteries and the Multi-State Lottery MEGA MILLIONS Product Group, the Rules of Operation of the Connecticut Lottery Corporation, Connecticut General Statutes or the Administrative Regulations of the Division of Special Revenue.

The “Connecticut MEGA MILLIONS” game described herein shall commence on December 2, 2010 and shall continue until the President publicly announces a termination date.

PART I LICENSE AGREEMENT

The Multi-State Lottery Association Board and the MEGA MILLIONS Group have entered into a license agreement (hereinafter referred to as the “Cross-Selling Agreement”) to sell the MEGA MILLIONS Lottery Game. MUSL has agreed, and MEGA MILLIONS Lotteries have approved, to act on the behalf of and to represent the MM Product Group in this licensing process. All provisions and requirements of that Cross-Selling Agreement are incorporated herein. Any conflict between the terms of these Game Rules and that Cross-Selling Agreement shall be interpreted in favor of the Cross-Selling Agreement, unless otherwise inconsistent with Connecticut statutes, regulations, instructions, operational rules and policies. The MEGA MILLIONS Lotteries shall determine the Advertised JACKPOT amount (cash value option and annuity) prior to each drawing, with the participation of the MM Product Group. The Game Rules and Finance and Operations Procedures of the MEGA MILLIONS Lottery Game, as adopted and amended by the MEGA MILLIONS Lotteries, are also incorporated herein. Any conflict between these Official Game Rules and Finance and Operations Procedures and these Official Game Rules shall be interpreted in favor of the MEGA MILLIONS Lottery Game Rules and Operations Procedures, unless otherwise inconsistent with Connecticut statutes, administrative regulations, instructions, operational procedures, rules of operation and policies.

PART II PURPOSE

- A. The purpose of the “Connecticut MEGA MILLIONS” game is to generate revenue for Connecticut’s General Fund through the operation of a specially-designed multi-state lottery game that will award prizes to ticket holders matching specified combinations of numbers randomly-selected in regularly scheduled drawings.
- B. The “Connecticut MEGA MILLIONS” game shall include an add-on game enhancement or multiplier feature called “MEGAPLIER” which will provide additional revenue for Connecticut’s General Fund by multiplying prize amounts for all prize tiers except the JACKPOT prize.

PART III DEFINITIONS

- A. “Add-on Game” or “Multiplier Feature” shall mean a game enhancement or option providing prize amounts in addition to the “Connecticut MEGA MILLIONS” prizes. The add-on game enhancement or multiplier feature shall not apply to the “Connecticut MEGA MILLIONS” Jackpot Prize.
- B. “Advertised Jackpot” shall mean the annuitized prize amount established by the MEGA MILLIONS Lotteries and the MUSL Product Group for each MEGA MILLIONS drawing.
- C. “Advance Action” shall mean the type of betting in which wagers may be placed, using the Advance Action option on the selection slip, for two (2), four (4), eight (8), ten (10) or twenty-six (26) consecutive drawings; OR using manual entry on the terminal from two (2) up to and including twenty-six (26) consecutive drawings. Advance Action betting shall always include the current drawing and may contain only single-board wagers.



- D. "Annual Audit" shall mean an annual financial audit conducted by an Independent Certified Public Accounting Firm which has been approved by MUSL to determine reimbursements and distributions of excess MEGA MILLIONS funds to the Connecticut Lottery Corporation.
- E. "Annuitized Payment Option" shall mean the manner in which the "Connecticut MEGA MILLIONS" JACKPOT Prize may be paid in annual installments. It is differentiated from the Cash Option in which the "Connecticut MEGA MILLIONS" winner elects to receive the JACKPOT Prize in one single lump sum cash payment. Selection of the payout option must be made within 60 days of when the winning ticket is presented for payment at CLC Headquarters.
- F. "Cash Option" or "Cash Value Option" shall mean the manner in which the "Connecticut MEGA MILLIONS" Jackpot may be paid in one single lump sum cash payment. It is differentiated from the Annuitized Payment Option in which the "Connecticut MEGA MILLIONS" winner elects to receive the JACKPOT prize in annual installments. Selection of the payout option must be made within 60 days of when the winning ticket is presented for payment at CLC Headquarters.
- G. "Centralized Automated Reporting System" or "CARS" shall mean the MUSL reporting system used by the On-Line Vendor to report "Connecticut MEGA MILLIONS" draw sales and winner selection results.
- H. "Claimant" shall mean any person or entity submitting a winning "Connecticut MEGA MILLIONS" ticket within the required prize claim period. A Claimant may be the purchaser, the person or entity named on the back of a signed "Connecticut MEGA MILLIONS" ticket, the bearer of an unsigned "Connecticut MEGA MILLIONS" ticket, or any other person or entity who may seek entitlement to a "Connecticut MEGA MILLIONS" prize payment in accordance with Connecticut General Statutes, Official Game Rules, Rules of Operation, Administrative Regulations, policies and validation requirements. No Claimant may assert rights different from the rights acquired by the original Purchaser at the time of purchase.
- I. "CLC", "Connecticut Lottery" or "Lottery" shall mean the Connecticut Lottery Corporation.
- J. "CLC Board of Directors" or "CLC Board" shall mean the 13-member body or duly-constituted committee thereof, governing the CLC and established pursuant to Public Act 96-212.
- K. "Connecticut MEGA MILLIONS Authorized Claim Center" shall mean a CLC Sales Retailer, CLC High-Tier Claim Center or CLC Headquarters where an official winning "Connecticut MEGA MILLIONS" ticket can be validated or cashed.
- L. "Connecticut MEGA MILLIONS Sales Retailer" shall mean a person or entity licensed by the Division of Special Revenue and authorized by the Connecticut Lottery Corporation to sell and redeem "Connecticut MEGA MILLIONS" lottery tickets.
- M. "Connecticut MEGA MILLIONS Promotion/Cross-Promotion" shall mean a marketing, advertising, public relations, publicity event or program approved by the MEGA MILLIONS Lotteries and the MM Product Group on behalf of its Party Lotteries licensed to sell the MEGA MILLIONS game to promote and/or cross-promote sales of the "Connecticut MEGA MILLIONS" game. Cross-promotions may consist exclusively of other lottery games, or may also consist of any other third-party goods, products or services, as well as any combination thereof, approved by the MEGA MILLIONS Lotteries, the MM Product Group, the CLC and the Division of Special Revenue.
- N. "Division of Special Revenue" or "Division" shall mean the Connecticut state agency that provides regulatory oversight of the CLC.
- O. "Draw Reporting Software" or "DRS" shall mean the software reporting system used by the CLC to report draw sales and winner selection results.
- P. "Drawing" shall mean the formal process of selecting winning numbers which conclusively determines the number of winners for each prize level of the game.



- Q. "Game Board(s)", or "Game Play(s)" shall mean that area of the play slip, also known as a "panel", which contains two sets of numbered squares to be marked by the player: the first set contains fifty-six (56) squares, numbered one (1) through fifty-six (56); the second set contains forty-six (46) squares, numbered one (1) through forty-six (46).
- R. "Game Ticket" or "Ticket" shall mean an acceptable evidence of play, which is a ticket produced by an on-line terminal meeting the specifications defined in these Official Game Rules.
- S. "Internal Control System" or "ICS" shall mean the computer system owned and operated by the CLC to verify transactions processed by the On-Line Gaming System.
- T. "Jackpot Prize" or "Grand Prize" shall mean the top prize in the "Connecticut MEGA MILLIONS" game. The JACKPOT is a pari-mutuel prize paid as an annuity in twenty-six (26) annual payments or as one single lump sum cash payment.
- U. "Jackpot Prize Amount" shall mean the prize amount awarded for matching all the numbers drawn from both matrix fields.
- V. "License" shall mean a business, operations and financial agreement executed between MUSL for its Party Lotteries and the MEGA MILLIONS Lotteries which authorizes cross sales of the Powerball and MEGA MILLIONS games into each other's lottery jurisdictions.
- W. "Licensee Lottery" shall mean a state lottery or lottery regulated by a governmental unit, political subdivision or entity thereof which is not a Party Lottery or Member Lottery but which has agreed to comply with all applicable MM Product Group requirements and has been authorized by the MM Product Group to sell that MM Product Group's game(s). Within the context of these Official Game Rules, the Licensee Lottery shall primarily refer to the Connecticut Lottery Corporation ("CLC") which has been authorized by the MM Product Group and licensed by the MEGA MILLIONS Lotteries to sell the "Connecticut MEGA MILLIONS" game.
- X. "MEGA MILLIONS Clearinghouse" shall mean the Virginia Lottery or any MEGA MILLIONS Party Lottery designated by the MEGA MILLIONS Group whose responsibility it is to collect and transfer JACKPOT funds from MEGA MILLIONS Lotteries to MUSL.
- Y. "MEGA MILLIONS Finance Committee" shall mean a Committee of the MEGA MILLIONS Lotteries which, along with participation of the MM Product Group, determines the JACKPOT Prize amount (cash value option and annuity).
- Z. "MEGA MILLIONS Lotteries or MEGA MILLIONS Group" shall mean those MEGA MILLIONS Lotteries which have joined under the MEGA MILLIONS Lottery Agreement; the group of lotteries that has reached a Cross Selling Agreement with the MM Product Group for the selling of the MEGA MILLIONS Game.
- AA. "MEGAPLIER" shall mean an optional add-on game enhancement or multiplier feature which a player selects at the time of ticket purchase costing an additional \$1.00 per board, play or panel.
- BB. "MEGAPLIER Number" shall mean a multiplier number (2, 3 or 4) randomly-selected and displayed during the drawing that increases the value of the set prize for those winners who have pre-selected the "MEGAPLIER" option. The MEGAPLIER number shall not apply to the JACKPOT Prize.
- CC. "MEGAPLIER Prize" shall mean a set prize amount that is determined by one of three weighted multiplier numbers (2, 3 or 4) randomly-selected at the drawing and increasing the set prize values. The top four set prize levels may become pari-mutuel and, if so, may be less than those published. In this case, the MEGAPLIER Prize for these four set prize levels will be calculated as a multiple of the revised pari-mutuel payout.
- DD. "MUSL" shall mean the Multi-State Lottery Association, a government-benefit association wholly owned and operated by the Party Lotteries.



- EE. "MUSL Board" shall mean the governing body of MUSL which is comprised of the Chief Executive Officer of each MUSL Party Lottery.
- FF. "MUSL Executive Director" shall mean the person who has primary responsibility for managing the daily operations of MUSL and for implementing the decisions of MUSL Board of Directors.
- GG. "MUSL Finance & Audit Committee" shall mean the committee established by the Multi-State Lottery Association Agreement.
- HH. "MUSL MEGA MILLIONS Product Group" or "MM Product Group" shall mean the group of MUSL Lotteries, of which the Connecticut Lottery Corporation is one, that has joined together to offer the MEGA MILLIONS lottery game product, pursuant to the terms of its Cross-Selling Agreement with the MEGA MILLIONS Lotteries, the Multi-State Lottery Agreement, Bylaws, and the MEGA MILLIONS Product Group Rules.
- II. "MUSL MEGA MILLIONS Product Group Chair" shall mean the MUSL Party Lottery appointed by MUSL Executive Director to effect decisions on behalf of MUSL.
- JJ. "MUSL Security & Integrity Committee" shall mean the committee established by the Multi-State Lottery Association Agreement.
- KK. "On-Line Lottery Game" or "Draw Game" shall mean a lottery game for which tickets are issued by an on-line terminal and in which a player selects numbers out of a larger pre-established field(s) of numbers.
- LL. "On-Line Gaming System" shall mean the computer wagering system owned and operated by the On-Line Vendor for the purpose of issuing and redeeming lottery tickets.
- MM. "On-Line Vendor" or "Vendor" shall mean the entity that operates the On-Line Gaming System on behalf of the CLC. The On-Line Vendor provides the wagering system and terminals used to produce and redeem "Connecticut MEGA MILLIONS" tickets.
- NN. "Pari-mutuel" shall mean the total amount of sales allocated to a given prize level divided by the number of winners at that level.
- OO. "Participating Lottery" or "Selling Lottery" shall mean a state lottery or lottery of a political subdivision or entity which is participating in selling the games offered by the MEGA MILLIONS Lotteries and which may be a member of either group.
- PP. "Party Lottery" or "Member Lottery" shall mean a state lottery or lottery of a political subdivision or entity which has joined the MEGA MILLIONS Lotteries and is authorized to sell the MEGA MILLIONS game. Unless otherwise indicated, Party Lottery or Member Lottery does not include "Licensee Lotteries".
- QQ. "Play" or "Bet" shall mean the six (6) numbers (the first five (5) from a field of fifty-six (56) numbers and the last one (1) MEGA BALL number from a field of forty-six (46) numbers) that appear on a ticket as a single-lettered play, board or panel.
- RR. "Play Slip", or "Selection Slip", or "Bet Slip" shall mean a card used in marking a player's game boards, plays or panels.
- SS. "Player" or "Purchaser" shall mean a person(s), entity or entities who buy "Connecticut MEGA MILLIONS" tickets in accordance with the Official Game Rules, state and federal statutes, administrative regulations, rules and policies.
- TT. "President & CEO" or "President" shall mean the President of the Connecticut Lottery Corporation.
- UU. "Prize Fund" or "Prize Fund Percentage" shall mean the portion of "Connecticut MEGA MILLIONS" sales set aside for the payment of prizes.



- VV. "Prize Liability Cap" or "Liability Threshold" shall mean the maximum draw liability allowed to sustain the set prize amounts, after which point the set prizes are calculated on a pari-mutuel basis.
- WW. "Quick Pick" or "Computer Pick" shall mean the random selection of six (6) numbers by the on-line gaming system, which appear on a "Connecticut MEGA MILLIONS" ticket and are played by a player in the game.
- XX. "Reserve Account" shall mean the portion of "Connecticut MEGA MILLIONS" sales set aside to offset contingent prize expenses and operating expenses. Reserve amounts shall be held in trust and invested by MUSL until such time as the account balances reach a threshold amount designated by MUSL.
- YY. "Set Prize" shall mean all other prizes, except for the JACKPOT prize, that are advertised to be paid by a single lump sum cash payment and, except in pari-mutuel instances outlined in these Official Game Rules, are equal to the prize amount established by the MEGA MILLION Lotteries for the prize level.
- ZZ. "Subscription Ticket" shall mean an extended, multi-draw purchase option wherein the same set(s) of numbers may be played for a specified number of consecutive drawings. The subscription ticket shall be effective on a future date as prescribed by the governing laws, policies and rules of the MUSL and/or MM Party Lottery offering the subscription option. Subscription tickets are distinguished from Advance Action tickets in that Advance Action tickets are effective starting from the next scheduled drawing of the game.
- AAA. "Terminal" shall mean a device authorized by the CLC to function in an on-line, interactive mode with the CLC's On-Line Gaming System for the purpose of issuing lottery tickets and entering, receiving and processing lottery transactions, including selling and validating tickets and transmitting reports.
- BBB. "Winning Numbers" shall mean the six (6) numbers (the first five from a field of fifty-six (56) numbers and the last one (1) MEGA BALL number from a field of forty-six (46) numbers) that are randomly selected at each drawing and used to determine the winning plays contained on a game ticket.

PART IV OPERATIONAL PROCEDURES

1. On-Line Gaming System Requirements. The CLC's On-Line Gaming System shall be configured as a duplex system and shall have a backup power supply so that if one system fails, processing can continue. The gaming systems, including computer hardware and software, must be approved by the MUSL Security & Integrity Committee before use. All changes to the On-Line Gaming System that could affect the "Connecticut MEGA MILLIONS" game must be reported in advance to the MM Product Group.
 - a. Centralized Automated Reporting system (CARS). The CLC shall direct transmission of gaming system data and information (draw sales, pool closing time, winning number verification and winner selection) from its On-Line Vendor to MUSL through the use of approved reporting software and procedures (Centralized Automated Reporting System or CARS) to MUSL. CARS will be used as a secondary and automatic process to verify that "Connecticut MEGA MILLIONS" draw information is balanced between the On-Line Gaming System and the CLC's Internal Control System. MUSL will verify receipt of pool closing and draw sales information and, once confirmed, will send official notification on behalf of the CLC to the MEGA MILLIONS Group.
 - b. Draw Reporting Software (DRS). The CLC shall transmit pool closing and draw sales information to MUSL prior to the drawing and no later than the official time established by MUSL. MUSL shall confirm receipt of pool closing and draw sales information and shall notify the MEGA MILLIONS Group on behalf of the CLC. After the drawing, the CLC shall transmit winner by tier information to MUSL.
 - c. Ticket Validation. The CLC shall validate any apparent winning "Connecticut MEGA MILLIONS" ticket sold on its On-Line Gaming System using the Ticket Validation Numbers. In addition, the CLC shall use the validation methods described in Part VII Section 20 (Ticket Validation Requirements) for all "Connecticut MEGA MILLION" tickets winning either the JACKPOT prize or a set prize.



- d. Ticket Stock Distribution. The CLC shall develop a method to confirm the serial numbers of the "Connecticut MEGA MILLIONS" ticket stock which is delivered to the Sales Retailers. This tracking shall be done in such a manner that the CLC's data processing staff shall not have access to such information. When there is a winning "Connecticut MEGA MILLIONS" JACKPOT ticket requiring validation, the CLC shall obtain serial numbers from the "Connecticut MEGA MILLIONS" ticket stock delivered to this Sales Retailer. These serial numbers shall be used to verify that the winning "Connecticut MEGA MILLIONS" ticket stock was issued by the selling Retailer.
 - e. Ticket Stock Sample. On the morning following each drawing, in the event of a Connecticut JACKPOT winner, the CLC Security Department shall retrieve a sample of the "Connecticut MEGA MILLIONS" ticket stock from the Sales Retailer's terminal selling the winning JACKPOT ticket. This "Connecticut MEGA MILLIONS" Ticket Stock shall be used for comparison with the actual winning "Connecticut MEGA MILLIONS" ticket to determine if the winning "Connecticut MEGA MILLIONS" ticket was produced by the Sales Retailer in question.
 - f. Transaction Found in Sync File. Winning "Connecticut MEGA MILLIONS" tickets requiring validation shall be verified and authenticated by confirming that the information contained on the "Connecticut MEGA MILLIONS" ticket is identical to the information contained on the sync file for the terminal where the winning "Connecticut MEGA MILLIONS" ticket was produced.
 - g. Ticket Verification. The ticket serial number information shall be obtained using the terminal number from Sales Retailer selling the apparent winning "Connecticut MEGA MILLIONS" Ticket. This information shall be used in conjunction with a software verification program written and installed by the On-Line Vendor to confirm the security code on the "Connecticut MEGA MILLIONS" Ticket.
 - h. Dual Security. Validation of winning "Connecticut MEGA MILLIONS" tickets by any of the methods described within Part VII Section 20 (Ticket Validation Requirements) must be performed by the CLC's Security Department or any other designated CLC staff not under the supervision or control of the data processing department.
 - i. Disaster Recovery. The CLC must maintain a primary data center and a hot backup site. Ideally, the hot backup site should not be within the same local vicinity as the primary data center for improved disaster recovery capabilities. The hot backup site must be capable of processing "Connecticut MEGA MILLIONS" draw sales, winner selections and prize calculations, and ensure no loss of draw transactions if a catastrophic event occurs at the primary data center.
 - j. Draw Operations. The CLC is required to conduct draw-related operations in accordance with the Drawing Procedures established by MUSL and the MEGA MILLIONS Group. Upon completion of the drawing and verification of the drawing results, the CLC must ensure that winner selection and related prize amounts are promptly updated on the On-Line Gaming System in order to ensure timely validation and payment of "Connecticut MEGA MILLIONS" winning tickets.
2. Internal Control System ("ICS") Requirements. The CLC must maintain an Internal Control System for processing and recording "Connecticut MEGA MILLIONS" transactions in a "live feed" mode with its On-Line Gaming System. Except for the purpose of transmitting data in a secured manner, the ICS must not be connected to the On-Line Gaming System and must run independently of the On-Line Gaming System. The ICS must be owned, controlled and operated by the CLC. Its programmers and operators must not have physical or logical access to the On-Line Gaming System. At the close of draw sales, using the Draw Reporting Software Program, the CLC must report all "Connecticut MEGA MILLIONS" draw information which has been verified and processed by the ICS to MUSL.
- a. Daily Sales Transactions. The CLC must collect and balance "Connecticut MEGA MILLIONS" sales transactions every day. These sales records shall be processed using the CLC's ICS programs and balanced to the reports generated by the On-Line Gaming System.



- b. Drawing Day Sales Transactions. On the day of the MEGA MILLIONS drawing, sales transactions shall be processed and balanced throughout the course of the day so that imbalances are identified as soon as possible. When the drawing pools are closed, the CLC shall take possession of the entire drawing day's sales transactions records. The draw transactions must be reconciled by using the CLC's ICS Programs and balanced to the draw reports generated by the On-Line Gaming System. The CLC shall notify MUSL of such possession by using the Draw Software Program and shall certify that the pools are closed. If sales are not in balance, notification must be provided to the MEGA MILLIONS Group no later than 10:00am on the day following the drawing.
 - c. Winning Numbers Processing. Winning numbers shall be processed by CLC staff by using ICS programs and shall be balanced with the winning numbers report issued by the On-Line Gaming System.
 - d. Winner Selection. Winner selection shall be initiated by the On-Line Vendor after the winning numbers have been successfully input into the On-Line Gaming System. After winner selection has been completed, the On-Line Vendor shall transmit the number of winners for each prize level to MUSL which shall, in turn, transfer the information to the MEGA MILLIONS Group on behalf of the CLC. The MEGA MILLIONS Group shall compile and balance winner information from all participating jurisdictions. Prizes shall not be paid until the MEGA MILLIONS Group confirms that all jurisdictions are in balance and authorizes the On-Line Vendor to initiate payment of prizes.
3. Operations Reviews. The CLC shall be subject to an annual review of its operational procedures and controls by MUSL.
 4. Annual Audits. On an annual basis, all MEGA MILLIONS accounts, transactions and processes shall be subject to annual audits conducted by independent auditors retained by MUSL. All such records and transactions shall be available to the Party Lotteries for copying, inspection and auditing purposes as may be required under the laws of their jurisdiction.
 5. Annual Operating Budget. By April 1st of each year, the MUSL Executive Director shall prepare and submit to the Product Group Chair, a budget of the estimated expenditures of the MM Product Group for the fiscal year beginning July 1st, and estimate the portion of the total budget to be paid to MUSL by each of the Party Lotteries in accordance with estimated sales. An acceptable method of payment shall be determined by the MM Product Group, subject to approval by the Board,


PART V DRAWING PROCEDURES

The MUSL Executive Director shall establish, with MM Product Group approval, the minimum drawing procedures to be established for the drawing and shall work with the lottery conducting the drawing to implement the procedures. The drawing procedures shall provide that a minimum of fifteen (15) minutes elapse between the close of the game ticket sales and the time of the drawing for those tickets sold. All drawings shall be open to the public and shall be witnessed by an Independent Certified Public Accounting Firm and other MUSL officials as may be required by jurisdictional statute. Any equipment used in a drawing shall be inspected and tested by the draw officials in the presence of an Independent Certified Public Accounting Firm, both before and after the drawing. All drawings, inspections and tests shall be recorded.

PART VI GAME LOGO

The CLC shall be authorized and licensed by MUSL to use the following official game logo of the MEGA MILLIONS game.

PART VII GAME DESCRIPTION

1. TICKET PRICE

- a. Uniform Price. Each "Connecticut MEGA MILLIONS" play shall be sold at retail for the price set by the MM Product Group.
- b. Taxes. The ticket price set by the MM Product Group shall include all the applicable taxes which a Party Lottery and/or Licensee Lottery may be required to collect.
- c. Cost Per Play. Official "Connecticut MEGA MILLIONS" tickets may be purchased for \$1.00 per play, or multiples thereof, in accordance with these Official Game Rules. The Purchaser receives one play for each \$1.00 wagered.
- d. Discounts, Rebates and Promotions. The CLC may offer tickets through discounts, rebates or promotions, without MM Product Group approval, for a period not to exceed ninety (90) days in any six-month period, as long as the full prize share is paid to the MM Product Group, without discount and after a notice advising all Group members of the terms and dates of the offering.
- e. Tickets as Prizes. The CLC may offer "Connecticut MEGA MILLIONS" tickets as a prize in any other CLC game or as a promotion after advising all members of the MM Product Group of the terms and dates of the promotion. A Selling Lottery may offer other discounts, rebates or promotions as may be approved by the MUSL Product Group.
- f. Contribution to Prize Pool. The CLC may offer "Connecticut MEGA MILLIONS" tickets as a prize or as part of an authorized discount, promotion or rebate provided that such discounted or promotional sales are assessed and reported to the prize pool at the full gross sales amount.

2. TICKET SALES

- a. Authorized Sales Retailers. "Connecticut MEGA MILLIONS" tickets shall be sold only through Sales Retailers licensed by the Division of Special Revenue and authorized by the CLC. Tickets shall be sold in accordance with the Official Game Rules, state and federal statutes, administrative regulations, rules and policies.
- b. Ticket Stock. "Connecticut MEGA MILLIONS" tickets shall be sold through the CLC's On-Line Gaming System and, other than subscription plays, shall be printed on ticket stock which meets the security requirements for ticket stock used for the CLC's other on-line lottery games.
- c. "Connecticut MEGA MILLIONS" Markings. All play slips used in the "Connecticut MEGA MILLIONS" game shall be conspicuously marked to indicate that the play slip pertains to the "Connecticut MEGA MILLIONS" game and shall contain other markings as may be required by the MUSL Board and MM Product Group.



- d. Game Sell-Out Prohibited. The CLC shall not directly and knowingly sell a ticket or combination of tickets to any person or entity that would guarantee such Purchaser a “Connecticut MEGA MILLIONS” JACKPOT win.
 - e. Location and Method of Sales. An offer to buy and an offer to sell a ticket in the “Connecticut MEGA MILLIONS” game shall be made only at licensed Sales Retailer locations.
3. PLAY CHARACTERISTICS AND RESTRICTIONS
- a. Ticket Sales to Minors Prohibited. “Connecticut MEGA MILLIONS” tickets may not be sold to or purchased by minors under the age of 18 years.
 - b. Ticket Cashing by Minors Prohibited. “Connecticut MEGA MILLIONS” tickets may not be cashed or redeemed by minors under the age of 18 years.
 - c. Ineligible Players. “Connecticut “MEGA MILLIONS” tickets shall not be purchased, and a prize won by any such ticket or share, either in whole or in part, shall not be paid to:
 - 1. A minor under the age of 18 years.
 - 2. A MUSL employee, officer or director.
 - 3. A contractor or consultant under agreement with MUSL to review the MUSL audit and security procedures.
 - 4. An employee of an Independent Certified Public Accounting Firm under contract with MEGA MILLIONS or MUSL to observe drawings or site operations and actually assigned to the MUSL account and all partners, shareholders or owners in the local office of the firm.
 - 5. A CLC employee or a CLC Board Member.
 - 6. An employee of the CLC’s On-Line Vendor.
 - 7. An employee of the CLC’s Advertising and Public Relations Provider.
 - 8. An employee of the CLC’s Print Vendors.
 - 9. An immediate family party (parent, stepparent, child, stepchild, spouse, sibling or person engaged in a domestic partnership or civil union) of an individual described in Subsections 1,2,3,4,5,6,7 or 8 residing as a member of the same household in the principle place of residence of any such person.
 - 10. Those persons designated by the CLC as ineligible to play the MEGA MILLIONS game in Connecticut shall also be ineligible to play the MEGA MILLIONS game in all other jurisdictions selling the MEGA MILLIONS game.
 - d. Ticket Cancellations Prohibited. An official “Connecticut MEGA MILLIONS” ticket may not be voided or canceled by returning the ticket to the selling Retailer or to the CLC. A “Connecticut MEGA MILLIONS” ticket accepted by the selling Retailer as a returned ticket and which cannot be resold shall be deemed as owned by the bearer thereof. This prohibition also applies to a “Connecticut MEGA MILLIONS” ticket that may be printed in error by the selling Retailer.
 - e. Claims. An official “Connecticut MEGA MILLIONS” ticket, subject to the validation requirements defined in Part VII Section 20 (Ticket Validation Requirements) of these Official Game Rules, shall be the only proof of a game play (or plays) and the submission of a winning ticket to the CLC or its licensed Sales Retailer shall be the sole method of claiming a prize or prizes. A play slip has no pecuniary or prize value and shall not constitute evidence of ticket purchase or of numbers selected. Lost “Connecticut MEGA MILLIONS” ticket claims shall not be honored or processed for payment or replacement.



- f. Use of Play Slips. Players may submit a completed "Connecticut MEGA MILLIONS" play slip to any licensed Sales Retailer to have issued an official "Connecticut MEGA MILLIONS" ticket. Play slips shall be available at no cost to the Purchaser and shall have no pecuniary or prize value, or constitute evidence of purchase or number selections. The use of facsimiles of play slips, copies of play slips, or other materials that are inserted into the terminal's play slip reader that are not printed or approved by the CLC is not permitted.
 - g. Manual Entry. Players may verbally convey their number selections to any licensed Sales Retailer for an official "Connecticut MEGA MILLIONS" ticket. Such number selections shall be manually entered into the on-line terminal by the licensed Sales Retailer.
 - h. Quick Pick. Players may either verbally request a Quick Pick "Connecticut MEGA MILLIONS" ticket from a licensed Sales Retailer or may select the Quick Pick option on the play slip and submit the completed play slip to any licensed Sales Retailer. Quick Pick shall be differentiated from Customer Select in that Quick Pick shall refer to the random selection of numbers made by the On-Line Gaming System rather than by the Player.
 - i. Customer Select. Players may select their own numbers by completing a "Connecticut MEGA MILLIONS" play slip or by verbally conveying their number selections directly to any licensed Sales Retailer. Customer select shall be differentiated from Quick Pick in that Customer Select shall refer to number selections made by the Player rather than the On-Line Gaming System.
 - j. Player Activated Terminals or Self-Service Terminals. If authorized, Players may utilize Player Activated Terminals (PATs) or Self-Service Terminals (SSTs) for the purchase of official "Connecticut MEGA MILLIONS" tickets.
 - k. Play It Again Feature. If authorized, Players may utilize the barcodes of already-purchased "Connecticut MEGA MILLIONS" tickets to duplicate another ticket of the same price and with the same number selections and options. To "Play It Again", Players may either make the request of a licensed Sales Retailer or may scan the barcode directly into a Player Activated or Self-Service Terminal.
 - l. 60-Day Prize Election Period. Players shall have 60-days from the date when the winning JACKPOT ticket is presented for payment at CLC Headquarters to decide whether the prize will be paid as a Cash Option or an Annuity Option. Once the option is selected, the player's decision is final and irrevocable. If the selection option is not exercised by the JACKPOT Prize winner within 60 days from the date when the winning ticket is presented for payment at CLC Headquarters, the CLC shall automatically issue payment as an Annuity Option. All winning tickets must be presented for payment within 180 days of the drawing date.
 - m. Advance Action. Official "Connecticut MEGA MILLIONS" tickets may be purchased for two (2) through twenty-six (26) consecutive drawings, beginning with the next scheduled or current drawing.
 - n. Limited to Highest Prize Won. In connection with the winning numbers drawn, the holder of a winning "Connecticut MEGA MILLIONS" ticket may win only one prize per board, play or panel, and shall be entitled only to the prize won by those numbers in the highest matching prize category.
 - o. Prize Claim Period. The CLC's prize claim period shall be 180 days from the date of the "Connecticut MEGA MILLIONS" drawing.
4. PRIZE PAYMENTS. The CLC may not pay prizes that are less than or more than the prize amounts established by the MEGA MILLIONS Lotteries and the MM Product Group. The prize won cannot be indirectly increased by CLC promotions or retailer promotions which have the effect of increasing the official designated "Connecticut MEGA MILLIONS" prize.



5. JACKPOT PRIZE ACCOUNTS.

- a. JACKPOT Funds Transferred to MUSL. The CLC shall transfer to MUSL in trust an amount determined by MUSL and the MM Product Group to be the CLC's total proportionate share of the prize account less actual low-tier prize liability. If this results in a negative amount, MUSL shall transfer funds to the CLC. If the CLC's share exceeds its statutorily-mandated prize payout, MUSL may adjust the transfer amounts over a period of time to permit payment of the CLC's full share in a manner complying with the CLC's prize payout laws. In the event of a JACKPOT win sold by the CLC or by any MUSL Party Lottery, the MEGA MILLIONS Clearinghouse shall collect the total proportionate share of the JACKPOT pool from the MEGA MILLIONS Lotteries and shall transfer that amount to MUSL within fifteen (15) calendar days from the winning draw.
- b. JACKPOT Funds Transferred to the CLC. JACKPOT prize amounts held by MUSL shall be transferred to the CLC having a winner in the "Connecticut MEGA MILLIONS" game, on a schedule approved by the MM Product Group and after MUSL has collected the prize pool shares from all MUSL Participating Lotteries selling the MEGA MILLIONS lottery game. For JACKPOT winners who select the annuity payment option, the CLC shall also receive the funds necessary to pay subsequent annuitized payments for the JACKPOT prize claim, which funds are held in trust by MUSL on behalf of the CLC.

6. UNCLAIMED PRIZES

- a. All funds to pay a JACKPOT Prize that goes unclaimed shall be returned to Selling Lotteries in proportion to sales by the Selling Lotteries for the Grand Prize in question after the claiming period set by the Selling Lottery selling the winning ticket expires. If after a winning MEGA MILLIONS ticket has not been claimed or redeemed and the corresponding prize monies have been returned to Selling Lotteries pursuant to this Rule, a subsequent claim is made or redemption sought which a Selling Lottery pays (i) as a result of the provisions of the Serviceman's Civil Relief Act (50 U.S.C.S. Appx. § 526); (ii) as a result of jurisdictional legislation adopted to satisfy the requirements of the Serviceman's Civil Relief Act; or (iii) as a result of jurisdictional legislation requiring such payment to a member of the armed forces who was engaged in active military service outside the paying Selling Lottery jurisdiction when the usual permitted time period to make a claim or seek redemption expired, each other Selling Lottery shall reimburse the paying Selling Lottery in an amount equal to the amount such other Selling Lottery would have contributed to the prize had the claim been made or redemption sought within the usual permitted time period for that claim or redemption. The provisions of this rule shall remain in force and effect and be binding upon the Party Lotteries without regard to whether the MEGA MILLIONS game remains in existence and/or whether the Selling Lottery seeking reimbursement has withdrawn from the game at the time a Selling Lottery seeks reimbursement pursuant to this rule.
- b. Unclaimed JACKPOT Prize funds shall be returned in proportion to sales and shall occur promptly upon the termination of the relevant claim period for the Participating Lottery in which the Unclaimed JACKPOT Prize ticket was purchased. Interest accretion on any securities purchased to fund the Unclaimed JACKPOT Prize will be reflected in market rates at the time of liquidation by the Purchaser of the securities. The Purchaser shall return interest earned on unclaimed cash JACKPOT Prizes based on the interest yields realized on such funds during the claim period.
- c. By agreement with the MEGA MILLIONS Lotteries, the MM Product Group will not participate in the sharing of liabilities at the low-tier prize level (all prizes below the JACKPOT Prize) and shall not allocate unclaimed low-tier prizes with the MEGA MILLIONS Lotteries.

7. FUNDS TRANSFER BY CLC.

The CLC shall transfer funds (i.e. draw receivables) at least weekly by wire transfer, electronic funds transfer, or by other means acceptable to the MM Product Group. The amount to be transferred shall be calculated in accordance with MM Product Group rules. If MUSL is unable to collect all funds in a timely manner for the transfer to the winning Lottery or Lotteries, MUSL may borrow the funds from other appropriate cash reserves, following notice to the MM Product Group Officers, the Finance & Audit Committee, and the Executive Committee. The borrowed funds shall be immediately replenished upon collection of prize funds from the Party Lotteries. The following paragraphs define explicitly the schedule for draw receivables and jackpot payments.



- a. Funds (i.e. draw receivables) shall be collected weekly from the MUSL Lotteries on the Monday or first banking day which is thirteen (13) days from the applicable Tuesday drawing and ten (10) days from the applicable Friday drawing.
 - b. MUSL shall transfer the JACKPOT prize share to the MEGA MILLIONS Clearinghouse within fourteen (14) calendar days from the date of the winning draw at a **MEGA MILLIONS Lottery**.
 - c. The MEGA MILLIONS Clearinghouse shall collect the funds from the MEGA MILLIONS Lotteries and shall transfer their JACKPOT prize share to MUSL within fourteen (14) calendar days from the date of a winning draw **at a MUSL Party Lottery**.
8. JACKPOT FUNDS.
Funds (i.e. jackpot shares) shall be collected by MUSL on behalf of the Selling Lotteries and shall be transferred to the Selling Lottery as determined by the MM Product Group and the MEGA MILLIONS Group.
9. REVENUES TO REMAIN WITH THE SELLING LOTTERY. Revenues not allocated to prizes, prepaid prize funds or operating costs and generated within each Selling Lottery shall remain with that Lottery.
10. ADVANCE SALES.
Proceeds from Advance Sales may be held by the CLC until the draw date for the ticket applies.
11. RESERVE ACCOUNTS.
- a. Trust Accounts. The reserve accounts shall be held in trust and invested by the MM Product Group on behalf of its Party Lotteries licensed to sell the MEGA MILLIONS game.
 - b. Determination of Use. The reserve accounts shall be used to augment prize amounts and/or for operating expenses including, but not limited to, the purchase of securities, annual audits and differences between estimated prizes and actual prizes, as determined by the MM Product Group.
12. INTEREST INCOME ON RESERVE ACCOUNTS.
- a. Interest earned on funds held in reserve accounts shall be used to offset operating expenses.
 - b. Interest income earned on the reserve accounts shall accumulate to the reserve accounts and held in trust until the account balances match the threshold amount designated by the MUSL Finance & Audit Committee. The investment balances for the reserve accounts shall be held in trust by MUSL for the benefit of each Licensee Lottery authorized to sell the MEGA MILLIONS game.
 - c. The reserve accounts shall be held in trust by the MM Product Group. Each MM Product Group Lottery share will be determined annually based on its sales as a percent of total game sales. The CLC shall instruct MUSL annually on the disposition of its share of the reserve accounts fund. With the approval of MUSL and the CLC, the reserve accounts fund may be used to pay the CLC's share of annual "Connecticut MEGA MILLIONS" operating expenses and/or be returned to the CLC to increase the CLC's contribution to the General Fund.
13. ANNUITIZED PAYMENTS.
MUSL shall act as an agent for the CLC and all other lotteries participating in the MM Product Group requiring annuitized payments and shall purchase government securities for the benefit of the lotteries who receive valid claims for each prize paid as an annuity. The annuity purchase process (solicitation of bids, selection of terms, premium payment, etc.) shall be handled by MUSL. The government securities so purchased shall be held in a trust account for the benefit of each lottery for eventual distribution to a prize winner. For those lotteries participating in the MM Product Group whose laws, executive orders or rules promulgated by an authority superior to the Lottery require their jurisdiction to purchase and hold securities for the payment of annuitized prizes in their jurisdiction may do so, but MUSL and the Licensee Lotteries in that MM Product Group shall not be liable for any losses in the event of such Lottery's default with respect to such annuities.



14. TIME, PLACE AND MANNER OF CONDUCTING MEGA MILLIONS DRAWINGS.

- a. Current draw sales for the "Connecticut MEGA MILLIONS" game shall close a minimum of fifteen (15) minutes before the draw.
- b. Drawings shall be conducted at the time(s) and day(s) established by the MEGA MILLIONS Lotteries.
- c. Drawings shall be conducted at physical location(s) established by the MEGA MILLIONS Lotteries.
- d. Drawings may be broadcast live or video-streamed over the internet as established by the MEGA MILLIONS Lotteries.
- e. The day, time and location of the drawings may be modified by the MEGA MILLIONS Lotteries.
- f. The MEGA MILLIONS winning numbers shall be randomly drawn.
- g. The add-on MEGAPLIER number shall be drawn, using a Random Number Generator, as part of the MEGA MILLIONS drawing.
- h. Drawings shall be open to the public and shall be witnessed by an Independent Certified Public Accountant Firm and any other CLC officials as may be required by jurisdictional laws or rule. All drawing equipment used shall be examined immediately prior to, as well as immediately after, the drawing.
- i. Drawing equipment shall be inspected and tested by the draw officials in the presence of an Independent Certified Public Accountant Firm, both before and after the drawing. All drawings, inspections and tests shall be recorded.

15. GAME DESIGN.

The "Connecticut MEGA MILLIONS" game is a double matrix game with two separate fields of numbers. In Field #1, the player must select five (5) different numbers from one (1) through fifty-six (56); in Field #2, the player must select one (1) MEGA BALL number from one (1) through forty-six (46). The MEGA BALL number in Field #2 may be the same as any one of the first five numbers selected by the player in Field #1. The game will be drawn on the day(s), time(s) and location(s) determined by the MEGA MILLIONS Lotteries and pays the JACKPOT prize either as an annuity or as a cash value option. Except as provided in these Official Game Rules for pari-mutuel prizes, all other prizes are paid on a set cash basis.

16. GAME PRIZE STRUCTURE.

- a. Prize Pool. The total prize pool for all prize categories offered by the Party Lotteries shall consist of up to fifty-five percent (55%) of each drawing period's sales, including any specific statutorily-mandated tax of a Selling Lottery to be included in the price of a lottery ticket, after the prize reserve accounts are funded to the amounts set by the MM Product Group, but may be higher or lower based upon the number of winners at each prize level, as well as the funding required to meet the Guaranteed Annuity Jackpot Prize, as may be required in Section VII Paragraph 17a. Any amount remaining in the prize pool or reserves and set aside for the Party Lotteries at the end of this game shall be carried forward to a replacement game or expended in a manner as directed by the MM Product Group in accordance with jurisdiction law.
- b. Prize Reserve Accounts. An amount up to five percent (5%) of the MUSL Party Lotteries' sales, including any specific statutorily-mandated tax of a MUSL Party Lottery to be included in the price of a lottery, shall be added to a MUSL Party Lottery's JACKPOT Prize Pool contribution and placed in trust in one or more reserve accounts held by the MM Product Group at any time that the MUSL Party Lottery's share of the reserve accounts is below the amounts designated by the MM Product Group. The MM Product Group, with approval of the Finance & Audit Committee, may establish a maximum balance for the reserve accounts. The MM Product Group may determine to expend all or a portion of the funds in the accounts for the payment of prizes or special prizes in the game, subject to the approval of the Finance & Audit Committee. The shares of a MUSL Party Lottery may be adjusted



with refunds to the MUSL Party Lottery from the reserve accounts as may be needed to maintain the approved maximum balance and balances of the MUSL Lotteries. Any amount remaining in a reserve account at the end of this game shall be carried forward to a replacement reserve account or expended in a manner as directed by the MM Product Group in accordance with local jurisdiction law. The MUSL Mega Millions Game Group shall decide the amount to be deducted from the Jackpot Prize category, up to a maximum deduction of up to five percent (5%) to build a prize reserve for payment of prizes. The MEGA MILLIONS reserve accounts and any MEGA MILLIONS set prize rollover monies, to the extent they exist, may be used to fund a deficiency in MEGAPLIER prizes.

- c. Expected Prize Payout Percentages. The following table sets forth the expected prize payout percentages for the “Connecticut MEGA MILLIONS” game. The JACKPOT shall be determined on a pari-mutuel basis. Except as provided in these rules and except for winning prizes sold by the California Lottery, all other prizes awarded shall be paid as set cash prizes with the following expected prize payout percentages, which does not include an additional amount held in prize reserves.

* The JACKPOT prize will be calculated on a pari-mutuel basis and shall not be less than \$12,000,000.

** These prize levels (**Prize Level #2 to Prize Level #5**) are subject to the Prize Liability Cap and may be less than the published set amounts. If the total game prize liability exceeds 300% of draw sales, including current JACKPOT sales but excluding California’s sales and prizes and excluding jackpot carry-forward, or 50% of draw sales plus \$50,000,000, whichever is lesser, these prizes will be calculated on a pari-mutuel basis according to the text specifications detailed in Section VII Paragraph 16c.iii and the mathematical formula set forth in Attachment A.

*** The remaining prize levels (**Prize Level #6 to Prize Level #9**) will be set prizes.

- i. The JACKPOT amount shall be divided equally by the number of game boards or plays winning the JACKPOT prize.
- ii. Except for the winning prizes sold by the California Lottery, the prize pool percentages allocated to the set prizes (the cash prizes of \$250,000 or less) shall be carried forward to subsequent draws if all or a portion of it is not needed to pay the set prizes awarded in the current draw.



- iii. **Liability Cap.** If the total prize liability for all participating lotteries selling the MEGA MILLIONS game (exclusive of the JACKPOT prize carry-in) exceeds three hundred percent (300%) of draw sales, including current draw jackpot sales but excluding California's sales and prizes, or fifty percent (50%) of draw sales plus \$50,000,000, whichever is less (both hereinafter referred to as the "Liability Cap"), the second through fifth prizes (\$250,000, \$10,000, \$150 and \$150 prize levels) shall be paid on a pari-mutuel basis, provided, however, that in no event shall the pari-mutuel prize be greater than the official Advertised JACKPOT prize. The amount to be used for the allocation of such pari-mutuel prizes (Prize Level #2 through Prize Level #5) shall be the liability cap less the amount paid for the JACKPOT prize and Prize Level #6 through Prize Level #9 (\$10, \$7, \$3 and \$2 prize levels). To fund their portion of the Liability Cap, the Party Lotteries may utilize either (a) the amount allocated to the set prizes and carried forward from previous draws, if any; or, (b) an amount from the reserve accounts. The California Lottery is excluded from this calculation for the low-tier prizes.

In the event that the Liability Cap is met, the amount to fund the JACKPOT Prize, together with the amounts to fund Prize Level #6 through Prize Level #9, shall be first paid from the Liability Cap amount. The balance of the Liability Cap, after deducting the JACKPOT prize and payment of Prize Level #6 through Prize Level #9 (hereinafter referred to as the "Liability Cap Balance") shall be applied to Prize Level #2 through Prize Level #5 on a pari-mutuel basis in accordance with the following formula:

1. Prize Level#2 (normally \$250,000) shall be an amount equal to 64.51% of the Liability Cap Balance, divided by the number of winners in Prize Level #2.
 2. Prize Level #3 (normally \$10,000) shall be an amount equal to 14.63% of the Liability Cap Balance, divided by the number of winners in Prize Level #3.
 3. Prize Level #4 and Prize Level #5 (normally each \$150.00) shall be an amount equal to 20.84% of the Liability Cap Balance, divided by the number of combined winners in Prize Level #4 and Prize Level #5.
- iv. Except as may be required in Section VIII Paragraph 17a, the official Advertised JACKPOT Annuity amount is subject to change based on sales forecasts and/or actual sales.
 - v. Subject to the laws and rules governing each Selling Lottery, the number of prize levels and the allocation of the prize fund among the prize levels may be changed at the discretion of the MEGA MILLIONS Lotteries, for promotional purposes. Such change shall be announced by public notice.
- d. **Probability of Winning and Expected Number of Winners.** The following table sets forth the probability of winning and the probable distribution of winners in and among each prize level, based upon the total number of possible number combinations in "Connecticut MEGA MILLIONS". All prize winners sold by the California Lottery are paid on a pari-mutuel basis.

** These prize levels (**Prize Level #2 to Prize Level #5**) are subject to the Prize Liability Cap and may be less than the published set amounts. If the total game prize liability exceeds 300% of draw sales, including current draw jackpot sales but excluding California's sales and prizes, or 50% of draw sales plus \$50,000,000, whichever is lesser, these prizes will be calculated on a pari-mutuel basis according to the text specifications detailed in Section VII Paragraph 16c.iii and the mathematical formula set forth in Attachment A.

*** The remaining prize levels (**Prize Level #6 to Prize Level #9**) will be set prizes.

e. JACKPOT Prize.

1. Prior to each MEGA MILLIONS drawing, the MEGA MILLIONS Lotteries and the MUSL MM Product Group shall determine the Annuitized JACKPOT Prize amount to be advertised, as well as the estimated Cash Equivalent JACKPOT Prize amount. Except as otherwise provided, the Advertised JACKPOT amount shall be the basis for determining the amount of prize money to be awarded for each winning MEGA MILLIONS board, play or panel matching all five (5) of the winning numbers in Field #1 and the one (1) winning MEGA BALL number in Field #2.
 - a. When there is only one official winning JACKPOT ticket, no Annuitized JACKPOT Prize shall be less than \$12,000,000.
 - b. If sales support a JACKPOT prize that is lower than \$12,000,000 or lower than the Advertised JACKPOT, the resulting JACKPOT to be paid will be the highest fully funded million plus \$12,000,000 or the Advertised JACKPOT, whichever is lower.
 - c. Under no circumstances shall the JACKPOT paid be less than the advertised amount of the immediately prior drawing.
2. In any MEGA MILLIONS drawing, if there are no winning boards, plays or panels which qualify for the Annuitized JACKPOT prize, the portion of the Prize Fund allocated to such JACKPOT prize category shall remain in the JACKPOT prize category and be carried over and added to the amount allocated for the JACKPOT prize category in the next consecutive MEGA MILLIONS drawing.



3. If the Annuitized JACKPOT Prize divided by the number of MEGA MILLIONS boards, plays or panels matching all five (5) of the MEGA MILLIONS winning numbers in Field #1 and the one (1) winning MEGA BALL number in Field #2 is equal to or greater than \$1,000,000, the JACKPOT prize may be paid as an Annuity Option.
4. If the Annuitized JACKPOT Prize divided by the number of MEGA MILLIONS boards, plays or panels matching all five (5) of the MEGA MILLIONS winning numbers in Field #1 and the one (1) winning MEGA BALL number in Field #2 is less than \$1,000,000, then each JACKPOT Prize winner shall be paid an amount equal to the Cash Option divided equally by the number of JACKPOT Prize winners. Each such JACKPOT Prize winner shall be paid in a single lump sum cash payment.
5. A Claimant selecting the JACKPOT Cash Option shall be paid in one single lump sum cash payment upon successful validation of the winning "Connecticut MEGA MILLIONS" ticket.
6. A Claimant selecting the JACKPOT Annuity Option shall be paid twenty-six (26) annual installments upon successful validation of the winning "Connecticut MEGA MILLIONS" ticket. The initial payment shall be paid when the winning ticket is presented for payment and successfully validated. The subsequent twenty-five (25) JACKPOT installments shall be paid annually within seven (7) days of the federal auction date, as shown below. Payment must be made on the maturity date of the purchased bonds but before the date of the win. For example, if a bond matures and is paid on February 22, 2010 for a prize won in a drawing on February 18, 2010, then the payment must be made on November 22, 2010.

7. The JACKPOT prize paid shall be the advertised amount, subject to change based on sales forecasts and/or actual sales. Additionally, the JACKPOT prize amount may be rounded up to the next highest multiple of one million dollars (\$1,000,000), at the discretion of the Party Lotteries.
- f. Set Prizes.
1. "Connecticut MEGA MILLIONS" boards, plays or panels matching five (5) winning numbers drawn for Field #1 but not matching the winning MEGA BALL number drawn for Field #2 (Match 5+0) shall be entitled to receive a **Second Prize of \$250,000**.
 2. "Connecticut MEGA MILLIONS" boards, plays or panels matching four (4) of the five (5) winning numbers drawn for Field #1 plus the winning MEGA BALL number drawn for Field #2 (Match 4+1) shall be entitled to receive a **Third Prize of \$10,000**.
 3. "Connecticut MEGA MILLIONS" boards, plays or panels matching four (4) of the five (5) winning numbers drawn for Field #1 but not matching the winning MEGA BALL number drawn for Field #2 (Match 4+0) shall be entitled to receive a **Fourth Prize of \$150.00**.
 4. "Connecticut MEGA MILLIONS" boards, plays or panels matching three (3) of the five (5) winning numbers drawn for Field #1 plus the winning MEGA BALL number drawn for Field #2 (Match 3+1) shall be entitled to receive a **Fifth Prize of \$150.00**.
 5. "Connecticut MEGA MILLIONS" boards, plays or panels matching two (2) of the five (5) winning numbers drawn for Field #1 plus the winning MEGA BALL number drawn for Field #2 (Match 2+1) shall be entitled to receive a **Sixth Prize of \$10.00**.



6. "Connecticut MEGA MILLIONS" boards, plays or panels matching three (3) of the five (5) winning numbers drawn for Field #1 but not matching the winning MEGA BALL number drawn for Field #2 (Match 3+0) shall be entitled to receive a **Seventh Prize of \$7.00**.
 7. "Connecticut MEGA MILLIONS" boards, plays or panels matching one (1) of the five (5) winning numbers drawn for Field #1 plus the winning MEGA BALL number drawn for Field #2 (Match 1+1) shall be entitled to receive an **Eighth Prize of \$3.00**.
 8. "Connecticut MEGA MILLIONS" boards, plays or panels matching none of the five (5) winning numbers drawn for Field #1 but matching the winning MEGA BALL number drawn for Field #2 (Match 0+1) shall be entitled to receive a **Ninth Prize of \$2.00**.
 9. Each "Connecticut MEGA MILLIONS" ticket entitling Claimants to **Prize Level #2 through Prize Level #9** shall be paid in one single lump sum cash payment.
 10. "Connecticut MEGA MILLIONS" boards, plays or panels entitling Claimants to **Prize Level #2* through Prize Level #5*** shall be paid as set prizes. These prize levels are subject, however, to the Prize Liability Cap. If the Prize Liability Cap is reached, these set prize levels shall be paid on a pari-mutuel basis and the prizes may be lower than the published set amounts.
- g. Prize Liability Cap.
1. The Prize Liability Cap is applied if the total prize liability exceeds the lesser of 300% of current adjusted draw sales (exclusive California's sales and prizes) or 50% of current adjusted draw sales plus \$50,000,000. The Prize Liability Cap excludes JACKPOT Prize carry-in from prior draws.
 2. When the total prize liability threshold is reached, the Prize Liability Cap will apply to **Prize Level #2 through Prize Level #5**. These prize levels shall be calculated on a pari-mutuel, rather than set, basis. The mathematical formula used for this calculation is appended hereto as Attachment A and the text specifications are provided in Section VII Paragraph 16c.iii.
 3. With respect to any pari-mutuel prize, the calculation shall be rounded down so that prizes are paid in multiples of one dollar.
17. JACKPOT PRIZE PAYMENT.
- a. JACKPOT Prize Pool.
 - i. The prize money allocated from the current MEGA MILLIONS prize pool for the JACKPOT Prize, plus any previous portions of prize money allocation to the JACKPOT Prize level in which no matching tickets were sold will be divided equally among all JACKPOT prize winners in all Participating Lotteries. The Annuity JACKPOT prize amount will be paid in twenty-six (26) annual installments. If a MEGA MILLIONS Lottery Law or rule requires that the official Advertised JACKPOT Annuity prize amount shall be the basis or a factor for determining the amount to be awarded for the MEGA MILLIONS JACKPOT, a play matching all five of the five MEGA MILLIONS winning numbers drawn for Field #1 and the one MEGA MILLIONS winning number drawn for Field #2, then it shall be funded by the Selling Lotteries in accordance with the formula set by the MEGA MILLIONS Lotteries. The MEGA MILLIONS Lotteries may set a minimum guaranteed annuity JACKPOT amount, which shall be advertised by the Selling Lotteries as the starting guaranteed annuity JACKPOT amount. The MEGA MILLIONS Lotteries have set the guaranteed starting JACKPOT amount at twelve million dollars (\$12,000,000).
 - ii. If in any MEGA MILLIONS drawing, there are no MEGA MILLIONS plays which qualify for the JACKPOT category, the portion of the prize fund allocated to such JACKPOT category shall remain in the JACKPOT prize category and be added to the amount allocation for the JACKPOT category in the next consecutive MEGA MILLIONS drawing.



- iii. JACKPOT prizes shall be paid, at the election of the Player made no later than sixty (60) days after the winning ticket is presented for payment, with either a per winner annuity or cash payment. If the payment election is not made by the Player within sixty (60) days after the winning ticket is presented for payment, then the prize shall be paid as an annuity prize. The election to take the cash payment may be made within sixty (60) days after the winning ticket is presented for payment. An election made after the winning ticket is presented for payment is final and cannot be revoked, withdrawn or otherwise changed.
- iv. In the event of a prize winner who selects the Cash Option, the prize winner's share will be paid in a single lump sum cash payment upon completion of internal validation procedures. The Cash Option amount shall be determined by the MM Product Group in accordance with the following stipulations:
 - (a) Unless a different method is required by MEGA MILLIONS Group Lottery law or rule, the Cash Option amount shall be determined by the JACKPOT pool contribution percentage.
 - (b) In cases controlled by MEGA MILLIONS Group Lottery law or rule, the Cash Option may be determined by dividing the JACKPOT annuity amount by a rate established by the MEGA MILLIONS Finance Committee prior to each drawing divided by the number of total JACKPOT winners or by the proceeds resulting from the sale of the annuity.
- v. Annual payment option JACKPOT prizes shall be paid in twenty-six (26) annual installments, upon completion of internal validation procedures. The initial payment shall be paid upon completion of internal validation procedures. The subsequent twenty-five (25) payments shall be paid annually to coincide with the Federal Auction Date on which the bonds were purchased to fund the annuity. All such payments shall be made within seven (7) days of the anniversary of the annual auction date. Payment must be made on the maturity date of the purchased bonds but before the date of the win. For example, if a bond matures and is paid on February 22, 2010 for a prize won in a drawing on February 18, 2010, then payment must be made on November 22, 2010.
- vi. If individual shares of the cash held to fund an annuity is less than \$250,000, the MM Product Group, in its sole discretion, may elect to pay the winners their share of the cash held in the JACKPOT Prize pool. All annuitized prizes shall be paid annually in twenty-six (26) payments funded by the annuity. Prize payments may be rounded down to the nearest one thousand dollars (\$1,000). Any breakage as a result of the rounding will be added to the initial payment.
- vii. Funds for the initial payment of an annuitized prize or the single lump sum cash prize shall be made available by MUSL, for payment by the MUSL Party Lottery, on a schedule approved by the MM Product Group. If necessary, when the due date for the payment of a prize occurs before the receipt of funds in the prize pool trust sufficient to pay the prize, the transfer of funds for the payment of the full lump sum cash amount may be delayed pending receipt of funds from the Party Lotteries or other lotteries participating in the MEGA MILLIONS Game. A MUSL Party Lottery may elect to make the initial payment from its own funds after validation, with notice to MUSL.
 - (a) The MM Product Group will immediately transfer funds to a MUSL Party Lottery reporting a winner after the MUSL Party Lottery validates the prize claim, subject to the approved collection schedule for a transfer within fourteen (14) calendar days and the availability of funds to make the transfer.
 - (b) JACKPOT prize amounts held by MUSL will be transferred to the MEGA MILLIONS Clearinghouse within fourteen (14) calendar days after a MEGA MILLIONS Lottery reports a winner.



- viii. In the event of the death of a lottery winner sold by a MUSL Party Lottery during the annuity payment period, the MUSL Finance & Audit Committee, in its sole discretion excepting a discretionary review by the MM Product Group, upon petition of the estate of the lottery winner (the "Estate") to the lottery of the jurisdiction in which the deceased lottery winner purchased the winning ticket, and subject to federal, state, district or territorial applicable laws, may accelerate the payment of all of the remaining lottery proceeds to the Estate. If such a determination is made, then securities and/or cash held to fund the deceased lottery winner's annuitized prize may be distributed to the Estate. The identification of the securities to fund the annuitized prize shall be the sole discretion of the Finance & Audit Committee or the MM Product Group.
 - b. Low-Tier Cash Prize Payments. All low-tier cash prizes (all prizes except the JACKPOT) shall be paid in cash through the Selling Lottery which sold the winning ticket(s). A Selling Lottery may begin paying low-tier cash prizes after receiving authorization to pay from the MUSL Central Office.
 - c. Prizes Rounded. Annuitized payments of the JACKPOT Prize or a share of the JACKPOT Prize may be rounded to facilitate the purchase of an appropriate funding mechanism. Breakage on an annuitized JACKPOT prize shall be added to the first cash payment to the winner or winners. Prizes other than the JACKPOT Prize which, under these rules, may become single lump sum payment, pari-mutuel prizes, may be rounded down so that prizes can be paid in multiples of whole dollars. Breakage resulting from rounding these prizes shall be carried forward to the prize pool for the next drawing.
 - d. Rolling JACKPOT. If the JACKPOT is not won in a drawing, the prize money allocation for the JACKPOT shall roll over and be added to the JACKPOT Pool for the following drawing.
18. JACKPOT PRIZE ESTIMATION.
- a. The Annuitized JACKPOT Prize amount shall be manually forecasted on each drawing day in a joint conference call with the MEGA MILLIONS Party Lotteries and MUSL on behalf of its MM Product Group. Additionally, the MEGA MILLIONS Party Lotteries and MUSL on behalf of its MM Product Group may compare sales forecasts at any other additional time during the week as may be necessary for possible adjustments to the Advertised JACKPOT prize amount.
 - b. A Cash Equivalent JACKPOT Prize amount shall be estimated prior to each drawing by multiplying the current annuitized prize amount by a discount factor established by the MEGA MILLIONS Finance Committee.
19. TICKET RESPONSIBILITY.
- a. Signature and Ownership of Ticket. Until such time as a subscription play is properly and validly registered, or until such time as a signature is placed on the back of a ticket in the area designated for signature, a ticket shall be owned by the bearer of the ticket. When a subscription play is properly and validly registered, or when a signature is placed on the ticket in the place designated, the person who has registered the ticket or whose signature appears in such area shall be the owner of the ticket and shall be entitled to any prize attributable thereto, subject to the validation requirements defined in Section VII Section 20 (Ticket Validation Requirements).
 - b. Multiple Signatures and Multiple Claimants. The manner of payment of prizes for valid winning tickets bearing multiple signatures, marks or names shall be determined by the rules of the Selling Lottery.
 - c. Lost or Stolen Tickets. The CLC shall not be responsible for lost or stolen "Connecticut MEGA MILLIONS" tickets.
 - d. Player Responsibility to Check Tickets. The Player of an official "Connecticut MEGA MILLIONS" ticket has the sole responsibility for verifying the accuracy and condition of the data printed on the ticket at the time of purchase. The placing of plays or wagers is done at the Player's own risk, through the Sales Retailer, who is acting on behalf of the Player in entering the play or plays.



- e. Retailer Errors. Neither the CLC nor the Selling Lotteries shall be responsible to the Claimant for "Connecticut MEGA MILLIONS" tickets issued or redeemed in error by a Sales Retailer.
- f. Reporting Errors. Winners are determined by the numbers drawn and verified by the Independent Certified Public Accountant responsible for auditing the MEGA MILLIONS drawing. The Selling Lotteries shall not be responsible for MEGA MILLIONS Winning Numbers reported in error.
- g. Subscription Plays. A receipt for a subscription play has no value and is not evidence of a play. A subscription play is valid only when registered by the CLC in accordance with CLC rules and regulations. The person(s) registering the play shall be the owner of the subscription play.

20. TICKET VALIDATION REQUIREMENTS

- a. To be a valid ticket and eligible to receive a prize, a "Connecticut MEGA MILLIONS" ticket shall satisfy all the requirements established by the CLC for validation of winning tickets sold through its On-Line Gaming System, as well as any other validation requirements adopted by the MM Product Group, the MUSL Board and published as the Confidential MUSL Minimum Game Security Standards. MUSL and the Party Lotteries shall not be responsible for tickets which are altered in any manner.
- b. Under no circumstances will a claim be paid without an official "Connecticut MEGA MILLIONS" ticket (or subscription) matching all game play, serial number and other validation data residing in the CLC's On-Line Gaming System. Such ticket (or subscription) shall be the only valid proof of the wager placed and the only valid receipt for claiming or redeeming such prize.
- c. In addition to the above, in order to be deemed a valid winning "Connecticut MEGA MILLIONS" ticket, all of the following conditions must be met:
 - 1. The validation data must be present in its entirety and must correspond, using the computer validation file, to the number selections printed on the ticket for the drawing date(s) printed on the ticket.
 - 2. The ticket must be intact.
 - 3. The ticket must not be mutilated, altered, reconstituted or tampered with in any manner.
 - 4. The ticket must not be counterfeit or an exact duplicate of another winning ticket.
 - 5. The ticket must have been issued by a licensed Sales Retailer on official ticket stock.
 - 6. The ticket must not have been stolen, to the knowledge of the CLC.
 - 7. The ticket must be submitted for payment in accordance with the authorized cashing and claiming procedures of the CLC.
 - 8. The ticket data must have been recorded on the CLC's On-Line Gaming System prior to the drawing and the ticket data must match this computer record in every respect. In the event of a contradiction between information as printed on the ticket and as accepted by the CLC's On-Line Gaming System, the wager accepted by the gaming system shall be the valid wager.
 - 9. The number selections, ticket serial number, validation data and the drawing date(s) of an apparent winning ticket must appear in the official file of winning tickets and a ticket with that exact data must not have been previously paid.
 - 10. The ticket must not be unregistered, defectively printed or printed/produced in error to the extent that it cannot be processed by the CLC.



11. There must not be any other breach of these "Connecticut MEGA MILLIONS" Game Rules in relation to the ticket which, in the opinion of the President, justifies invalidation.
 12. By submitting an official winning "Connecticut MEGA MILLIONS" ticket for validation, the Claimant agrees to abide by all applicable laws, rules, regulations, instructions, conditions and final decisions of the President.
 13. A ticket purchased in Connecticut must be validated and redeemed in Connecticut.
- d. An official "Connecticut MEGA MILLIONS" ticket submitted for validation which fails any of the preceding validation conditions shall be considered void, subject to the following determinations:
1. In all cases of doubt, the determination of the President shall be final and binding. However, the President may, at his/her option and in his/her sole discretion, replace an invalid ticket with a "Connecticut MEGA MILLIONS" ticket of equal sales value.
 2. In the event a defective ticket is purchased or in the event the CLC determines to adjust an error, the Claimant's sole and exclusive remedy shall be the replacement of such defective or erroneous ticket(s) with a "Connecticut MEGA MILLIONS" ticket of equal sales value.
 3. In the event a "Connecticut MEGA MILLIONS" ticket is not paid by the CLC and a dispute occurs as to whether the ticket is a winning ticket, the CLC may, at its option, replace the ticket as provided in Paragraph 1. This shall be the sole and exclusive remedy of the Claimant.
21. PROCEDURES FOR CLAIMING AND PAYMENT OF PRIZES.
- a. "Connecticut MEGA MILLIONS" prizes shall be redeemed or claimed only in Connecticut.
 - b. "Connecticut MEGA MILLIONS" prizes may be redeemed or claimed at CLC Headquarters, Sales Retailers or High-Tier Claims Centers. Retailers may cash winning tickets up to and including \$599; High-Tier Claims Centers may cash winning tickets up to and including \$5,000; winning tickets over \$5,000 must be cashed at CLC Headquarters, although any lower denomination may also be cashed at CLC Headquarters.
 - c. Claimants of a winning "Connecticut MEGA MILLIONS" tickets must comply with Connecticut's prize claim requirements. Winning "Connecticut MEGA MILLIONS" tickets are valid for 180 days from the date of the drawing.
 - d. In the event that a single "Connecticut MEGA MILLIONS" ticket contains two (2) or more winning game boards, plays or panels, the cumulative prize amount shall be claimed or redeemed in accordance with Connecticut's prize payment limits. Cumulative winnings less than or equal to \$599 may be cashed at any Sales Retailer; cumulative winnings up to and including \$5,000 may be cashed at any High-Tier Claim Center; cumulative winnings over \$5,000 must be cashed at CLC Headquarters.
 - e. State and federal withholding taxes, and any other statutorily required deductions, where applicable, shall be withheld from "Connecticut MEGA MILLIONS" prizes in such amounts as are required.
 - f. "Connecticut MEGA MILLIONS" prizes shall not be paid to any person(s) explicitly prohibited from playing the game as defined in Section VII Paragraph 3c and in accordance with governing state and federal laws, rules and regulations.
 - g. Subject to Connecticut laws and regulations relating to the public disclosure of "Connecticut MEGA MILLIONS" winners, the name and city/town of the JACKPOT winner shall be disclosed in a press release or press conference and the winner may be requested to participate in a press conference.



22. SUBSCRIPTIONS.

The CLC may offer for sale subscriptions to the "Connecticut MEGA MILLIONS" game.

- a. The maximum number of consecutive drawings encompassed by a subscription shall be one hundred four (104).
- b. In the event that a matrix change (or other game change that would require a phase out of the remaining subscription draws) is authorized for the "Connecticut MEGA MILLIONS" game, the CLC must determine the option(s) available to its subscription players for the balance of plays remaining on their subscriptions, in order to meet the effective date of the matrix change.
- c. Game play information for a subscription may be edited only when an error in the numbers entered has been identified, a change in the frequency of drawings occurs or a change in the game matrix occurs.
 1. A subscription may be edited to correct an error in the numbers entered before the time of the first drawing for which the subscription is effective. (Liability for any number entered in error is limited to the Selling Lottery which entered the number in error.)
 2. For a change in game matrix, or for errors in the numbers entered which are identified after the time of the first drawing, the Selling Lottery may correct the subscription play prospectively for the remaining number of draws on the subscription.
 3. The only other condition under which subscription game play may be edited is to correct the end date if there is a change in the frequency of MEGA MILLIONS drawings.

23. PROMOTIONS and CROSS-PROMOTIONS. The MEGA MILLIONS Lotteries and the MM Product Group may periodically decide to conduct special marketing, advertising, public relations or publicity events designed to increase sales of the "Connecticut MEGA MILLIONS" game. The specific details of each such promotion/cross-promotion shall be determined by the MEGA MILLIONS Lotteries and the MM Product Group. Participation by the CLC will be subject to any applicable regulatory and Board approval process.

24. ADD-ON GAME ENHANCEMENT or MULTIPLIER OPTION.

The "Connecticut MEGA MILLIONS" Megaplier promotion is a limited extension of the Mega Millions game and is conducted in accordance with the Mega Millions Game Rules and other lottery rules applicable to the Mega Millions Game except as may be amended herein. The promotion will begin at a time announced by the Party Lottery and will continue until discontinued by the Lottery. The promotion will offer to the owners of a qualifying play a chance to multiply or increase the amount of any of the eight lump sum Set Prizes (the lump sum prizes normally paying \$2 to \$250,000) won in a drawing held during the promotion. The JACKPOT is not a Set Prize and will not be multiplied or increased by means of the Megaplier promotion.

- a. Description.
 1. The MEGAPLIER option is a YES or NO selection made by the player at the time of ticket purchase.
 2. Each MEGAPLIER option costs an extra dollar (\$1.00) per board, play or panel.
 3. The MEGAPLIER option must be recorded at the CLC's On-Line Gaming System as a qualifying and valid play.
 4. The MEGAPLIER option, when selected, applies to all the boards, plays or panels on the ticket.
 5. The MEGAPLIER option is designated on the ticket as "MEGAPLIER – YES" or "MEGAPLIER – NO".
 6. The MEGAPLIER option is available on current draw, Advance Action and Subscription tickets.



7. The MEGAPLIER option is available on both Quick Pick and Customer-Select tickets.
8. "Connecticut MEGA MILLIONS with MEGAPLIER" tickets cannot be canceled.
9. The MEGAPLIER option applies only to winning plays or tickets. If the ticket is a winner and if the MEGAPLIER option has been pre-selected, the prize is multiplied by a factor of 2, 3 or 4 times, as determined in advance of the official MM drawing. The multiplier will not apply to the JACKPOT or to the Match 5+0 prizes. There may be a promotional MEGAPLIER option provided on a limited-time basis that will be offered to purchasers of MEGA MILLIONS with MEGAPLIER set prize winners.
10. The MEGAPLIER option applies exclusively to the eight lowest set prizes. In the case of the Match 5+0 prize, however, only the 4x multiplier is used.
11. The MEGAPLIER option will be guaranteed four times (4x) the value of the Match5+0* prize level, ensuring a \$1,000,000 prize for each Match 5+0 with MEGAPLIER winning ticket.

NOTE: *In rare circumstances, the Match 5+0 prize may be paid on a pari-mutuel basis and, as such, may be less than the guaranteed \$1,000,000.

12. The MEGAPLIER option will multiply either the set or pari-mutuel prize amount for **Prize Level #2 to Prize Level #5**, as herein defined; the MEGAPLIER option will multiply the set prize amount for **Prize Level #6 to Prize Level #9**.
- b. MEGAPLIER Drawings.
1. MUSL may conduct its own drawing, or may authorize a jurisdiction lottery to conduct on its behalf, a separate random "MEGAPLIER" drawing. Before each MEGA MILLIONS drawing, a single number (2, 3 or 4) shall be drawn. The MEGA MILLIONS Group may change one or more of these multiplier numbers for special promotions from time to time. In the event the multiplier drawing does not occur prior to the Mega Millions drawing, the multiplier number will be a four (4), which shall solely be determined by the lottery authorized to conduct the "Megaplier" drawing.
 2. A qualifying play is any single Mega Millions play for which the player pays an extra dollar for the Megaplier option play and which is recorded in that Party Lottery's central computer as a qualifying play.
 3. A qualifying play which wins one of the seven lowest set prizes (excluding the Match 5+0 prize) will be multiplied by the number selected, either two, three or four (2,3 or 4), in a separate random Megaplier drawing announced in a manner approved by the MM Product Group. The announced Match 5+0 prize, for players selecting the Megaplier option, shall be increased to \$1,000,000 (one million dollars) unless a higher limited promotional dollar amount is announced by the Group or unless a lower dollar amount is announced by the Group under its limitation of liability rules.
 4. MUSL will either itself conduct, or authorize a U.S. Lottery to conduct on its behalf, a separate random "Megaplier" drawing. Before each Mega Millions drawing, a single number (2,3 or 4) shall be drawn. The Mega Millions Group may change one or more of these multiplier numbers and/or the Match 5+0 Megaplier prize amount for special promotions from time to time.
 5. There will be twenty-one (21) weighted numbers from which the multiplier may be randomly selected. They are labeled as follows:

c. MEGAPLIER Prize Pools.

1. The prize pool for all MEGAPLIER prize categories offered by the Selling Lotteries shall consist of up to fifty-five percent (55%) of each drawing period's sales, as determined by the Game Group, including any specific statutorily-mandated tax of a Selling Lottery to be included in the price of a lottery ticket, after the Mega Millions prize reserve accounts are funded to the amounts set by the MM Product Group. Any amount remaining in the prize pool at the end of this game shall be carried forward to a replacement game or expended in a manner as directed by the MM Product Group in accordance with each Selling Lottery's applicable law.
2. Any amount not used to pay for multiplied prizes may be collected and placed in the rollover account or in trust in one or more prize reserve accounts until the prize reserve accounts reach the amounts designated by the MM Product Group.
3. The prize pool allocated to the MEGAPLIER set prizes shall be carried forward to subsequent draws if all or a portion of it is not needed to pay the set prizes awarded in the current draw or may be held in reserve accounts
4. The following table sets forth the prize pool percentages for each MEGAPLIER prize levels. An additional amount equal to approximately five percent (5%) of MEGAPLIER sales shall be collected as a prize reserve.

5. Any amount remaining in the prize pool at the end of this game shall be carried forward to the replacement game or expended in a manner as directed by the MM Product Group in accordance with each Participating Lottery's applicable law.
6. The prize pool percentage allocated to the Megaplier set prizes shall be carried forward to subsequent draws if all or a portion of it is not intended to pay the set prizes awarded in the current draw or may be held in a prize reserve account.
7. If the total of the original MEGA MILLIONS set prizes and the MEGAPLIER prize amounts awarded in a drawing exceeds the percentage of the prize pools allocated to the set prizes, then the amount needed to fund the set prizes (including the Megaplier prize amounts) awarded shall be drawn from the following sources in the following order: (1) the amount allocated to the set prizes and carried forward from previous draws (exclusive of JACKPOT prize carry-in and exclusive of California sales and prizes), if any; (2) an amount from the MEGA MILLIONS reserve accounts not to exceed the lesser of 300% of draw sales or 50% of draw sales plus \$50 million. If, after these sources are depleted, there are not sufficient funds to pay the set prizes awarded (including Megaplier prize amounts), then Prize Level #2 through Prize Level #5 shall become pari-mutuel prizes. The MEGA MILLIONS and MEGAPLIER prize pools shall be combined in the rare instance when the set prizes, pursuant to the rules, are paid on a pari-mutuel basis, so that



the multipliers, as provided for in the rules, will remain in effect for all applicable prize levels. The Match 5+0 prizes may be reduced as announced by the Mega Millions Product Group.

8. In the event that the "Connecticut MEGA MILLIONS" prize payouts become pari-mutuel (**Prize Level #2 through Prize Level #5**), the MEGAPLIER prizes will be calculated as a multiple of the revised pari-mutuel payouts.
9. Except as provided in these Official Game Rules, all set prizes shall be paid as lump sum prizes. Instead of the MEGA MILLIONS set prize amounts, qualifying MEGAPLIER plays will pay the amounts shown below when matched with the MEGAPLIER number drawn.

* In certain rare instances, the MEGA MILLIONS set prize amount may be less than the published amount. In such case, the seven lowest Megaplier prizes will be a multiple of the changed MEGA MILLIONS prize amount announced after the draw. For example, if the Match 4+1 Mega Millions set prize amount of \$10,000 becomes \$5,000 under the rules of the MEGA MILLIONS game, then a MEGAPLIER player winning that prize amount with a 4x multiplier would win \$20,000 (\$5,000 x 4 = \$20,000). The Match 5+0 prize with Megaplier options, which normally pays one million dollars (\$1,000,000), will be reduced by the same percentage as the Match 5+0 \$250,000 prize is reduced.

- d. Probability of Winning. The following table sets forth the probability of the various MEGAPLIER numbers being drawn during a single MEGA MILLIONS drawing, except that the Megaplier number for the Match 5+0 prize will be at least four (4x), meaning that the probability of the 4x multiplier being drawn for the Match 5+0 prize is 1 in 1. The MM Product Group may elect to run limited-time promotions that may increase the multiplier numbers.

e. Prize Payment.

1. Prize Payments. All MEGAPLIER prizes shall be paid in one single lump sum cash payment by the CLC upon successful validation. The CLC may begin paying MEGAPLIER prizes after receiving authorization to pay from the MUSL Central Office.
2. Prizes Rounded. Prizes which, under these rules, may become pari-mutuel, may be rounded down so that prizes can be paid in whole dollars. Breakage resulting from rounding these prizes shall be carried forward to the prize pool of the subsequent drawing.

PART VIII ADVERTISING

1. Unfair Advertising. No Selling Lottery may advertise, either directly or indirectly, that MEGA MILLIONS tickets sold in its jurisdiction offer better odds, better chances of winning, or better payoffs than MEGA MILLIONS tickets sold in other jurisdictions. This rule does not prohibit a Selling Lottery from offering retailer promotions or other creative promotions designed to increase the sale of MEGA MILLIONS tickets.
2. JACKPOT Amount. No Selling Lottery may advertise an estimated JACKPOT amount which is different than the Advertised JACKPOT amount provided by the Selling Lotteries.

PART IX GOVERNING LAW

1. In purchasing a ticket issued for “Connecticut MEGA MILLIONS”, the following provisions apply:
 - a. The Purchaser agrees to comply with and be bound by all applicable Connecticut and federal statutes, Administrative Regulations, Official Game Rules and Rules of Operation, as well as by Instructions, policies and decisions of the President of the Connecticut Lottery.
 - b. The Purchaser agrees to be bound to all applicable rules governing the MEGA MILLIONS game.
 - c. In purchasing a ticket, the customer agrees to comply with and abide by local jurisdiction law and all rules, regulations, and final decisions of the jurisdiction and all procedures established by the President, the MUSL Group and the MEGA MILLIONS Group for the conduct of the game.
2. Decisions made by the President, the MUSL Group and the MEGA MILLIONS Group, including the declaration of prizes and the payment thereof and the interpretation of these Official Game Rules, shall be final and binding on all Purchasers and on every person making a claim in respect thereof. In the event of conflict, however, between these Official Game Rules and Connecticut statutes, rules or regulations, the Connecticut statutes, rules and regulations shall control.

PART X FUNDS TRANSFER PROCESS

The following procedures document the timely and effective transfer of funds for draw receivables and jackpot payments. MUSL shall act as an agent for the benefit of the MM Product Group licensed to sell the MEGA MILLIONS game.

1. Funds (i.e. draw receivables) shall be collected weekly from the MUSL Lotteries on the Monday or first banking day which is thirteen (13) days from the applicable Tuesday drawing and ten (10) days from the applicable Friday drawing.



2. MUSL shall transfer the JACKPOT prize share to the MEGA MILLIONS Clearinghouse within fourteen (14) calendar days from the date of the winning draw at a **MEGA MILLIONS Lottery**.
3. The MEGA MILLIONS Clearinghouse shall collect the funds from the MEGA MILLIONS Lotteries and shall transfer their JACKPOT prize share to MUSL within fourteen (14) calendar days from the date of a winning draw **at a MUSL Party Lottery**.



ATTACHMENT A

Prize Liability Cap or Liability Threshold Analysis

If the total prize liability for MEGA MILLIONS Lotteries and the MM Product Group selling the MEGA MILLIONS game (exclusive of the JACKPOT prize carry-in) exceeds three hundred percent (300%) of draw sales, including current draw jackpot sales but excluding California's sales and prizes, or fifty percent (50%) of draw sales plus \$50,000,000, whichever is less, (both hereinafter referred to as the "Prize Liability Cap"), the second through fifth set prizes (\$250,000, \$10,000, \$150 and \$150 prize levels) shall be paid on a pari-mutuel basis in accordance with the formula set forth below, provided, however, that in no event shall the pari-mutuel prize be greater than the official Advertised JACKPOT prize. The amount to be used for the allocation of such pari-mutuel prizes (Prize Level #2 through Prize Level #5) shall be the Liability Cap less the prize amounts paid for the JACKPOT prize and Prize Level #6 through Prize Level #9 (\$10, \$7, \$3 and \$2 prize levels).

To fund their portion of the Liability Cap, MEGA MILLIONS Lotteries and the MM Product Group may utilize either (a) the amount allocated to the set prizes and carried forward from previous draws, if any; or, (b) an amount from the reserve accounts, if available, not to exceed the lesser of 300% of draw sales or 50% of draw sales plus \$50,000,000.
